**मीन्स स्कॉलरशिप के लिए पात्रता ELIGIBILITY FOR MEANS SCHOLARSHIPS:**

- a. The scholarship shall be provided to eligible student of the first, second and third year of the B.Sc. in H&HA who obtains the highest percentage of aggregate marks, the minimum being **60% marks in Fifth Semesters Final Exams & above B + Grade in First & Third Semester Examination.**
- b. The gross family income of the beneficiary from all sources **should not exceed Rs.3.00 lakhs (Rupees Three lakhs only) per annum.**
- c. The student being offered this scholarship should not be in the receipt of any other scholarship. If the student is already holding a scholarship/stipend etc. under some other scheme, he/she will be required to exercise his option of choosing the scholarship that he/she proposes to avail.
- d. The student is required to submit **an affidavit on non-judicial stamp paper of Rs.50/- (Rupees Fifty only) for Item B & C (as per format enclosed)**
- e. They are required to produce latest Income Certificate obtained from the competent authority on or after the issue of this notice i.e.,
